### Waiver and Release of Liability for Lions Special Kids Day: *District 4-C5 Lions Clubs for Lions Special Kids Day*

1. My family and I wish to participate in the District 4-C5 Lions Special Kids Day event (“Event”). I (we) understand that my execution of this Waiver and Release is a prerequisite for participation in the Event. I (we) further understand that there are risks and dangers inherent in participating in the Event.
2. I (we) understand that in order to be allowed to participate in the Event, I (we) agree to assume all risks and to release and hold harmless District 4-C5 Lions, Lions Education Foundation, Business Depot Park, Lions Clubs International Inc., Lions Clubs International Foundation, Inc., and their officers, agents, employees, assigns, successors in interest, contractors, vendors (and their agents), agencies, sponsors, officials and volunteers, including walk leaders, participating communities and clubs and all governmental and public entities including, but not limited to, the State, County and local municipalities where the events take place (collectively the “Released Parties”).

I (we) intend by this Waiver and Release to release, in advance, and to waive my and/or my family’s rights and discharge all of the persons and entities mentioned above, from any and all claims for damages for death, personal injury or property damage which I (we) may have, or which may hereafter accrue to me (us) as a result of my (our) participation in the Event, even though this liability may arise from negligence or carelessness on the part of the persons or entities being released, from dangerous or defective property or equipment owned, maintained or controlled by them or because of their possible liability without fault. I (we) understand and agree that this Waiver and Release is binding on my heirs, assigns, and legal representatives.
4. I (we) understand that I (we) am solely responsible for my and my family’s health and safety, and I (we) acknowledge that I (we) am physically capable of participating in and completing this Event.

Should any portion of this Waiver and Release be judicially determined invalid, voidable or unenforceable, for any reason, such portion of this Waiver and Release shall be severable from the remaining portions herein and the invalidity, voidability, or unenforceability thereof shall not affect the validity, effect, enforceability, or interpretation of the remaining provisions of this Waiver and Release.
